

**Resolution 2016-
Resolution Authorizing the Execution of “Fair and Open” Professional Services
Contracts with the Borough of Bradley Beach for the Provision of Professional Services**

WHEREAS, there exists a need for professional services to be provided to the Borough of Bradley Beach, County of Monmouth, New Jersey (the “Borough”) for the year January 1, 2016 through December 31, 2016; and

WHEREAS, the Borough has, through the fair and open process, publicly advertised for a Request for Proposals and Qualifications and said requests for Professional Services were received in the Office of the Municipal Clerk no later than 4pm on December 1, 2015; and

WHEREAS, the Borough has reviewed all proposals received and has determined that the Borough Council desires to authorize the execution of a professional services contract between following listed persons/firms and the Borough for the provisions of said services for the year 2015; and

WHEREAS, the Local Public Contracts law (N.J.S.A. 40A:11-1 et. seq.) requires a resolution authorizing the appoint for Professional Services.
