

MAY 10, 2017

A FORMAL meeting of the FLETCHER LAKE COMMISSION was held at 7:00 p.m. at the Bradley Beach Municipal Complex, after which the roll was called.

In attendance were Charles A. Quixley, Chairman; Robert Scholz, Treasurer; Susan Roach; Marc Rosenthal; Suzanne Klarewicz; Sal Galassetti; John Bauer; Lauren Rizzo, Linda Maxwell; and Olga Blum, Secretary.

Also present were Phyllis Quixley; Connie Ogden and Marie Voidt.

THE FOLLOWING SUBJECTS WERE DISCUSSED:

(1) The electric bills in the amounts of \$36.38, \$3.32 and \$3.32, for a total of \$43.02, were submitted to the Treasurer for payment. Klarewicz made a motion to pay the bills, which was seconded by Rosenthal, and carried.

(2) Balzarano told the Chairman that he installed 2 of the 3 aerators on the lake, but one of the motors is frozen. The estimated price last year was \$350. But he will shop around for the best price. Rosenthal made a motion to spend up to \$500 on the new motor. The motion was seconded by Roach, and carried.

(3) Flower pots were donated by Bradley Beach, and the Chairman already put out 14 pots around the lake. There is also a large pot inside the gazebo, but we can change it if we don't like it there. We will start planting the flowers this week, but we have much more to do there.

(4) Paint, brushes and rollers were purchased to paint the benches and foot bridge at a cost of \$160. Scholz made a motion to pay the bill of \$160. The motion was seconded by Rosenthal, and carried.

(5) Galassetti reported on the flowers we are going to plant, and said that the Flower Committee would like an input of the kind of flowers we plant.

(6) The Chairman said we need the help of the PW Department to help us remove the sand from the gazebo area, put up some more fences, and also to turn on the water and the electricity.

(7) Chairman wasn't able to get in touch with Mr. Force, but will try again this week.

(8) THE FOLLOWING SUBJECTS WERE ALSO DISCUSSED: Our helper has another job at Nagle's; report of 19 eggs being oiled; stocking the lake with fish; plantings will start soon; fundraiser; getting a brick for Mockridge.

A motion was made by Rosenthal to buy a brick for Mockridge for his years of service on his retirement. The motion was seconded by Scholz, and carried.

Scholz made a motion to adjourn the meeting at 8:00 p.m. The motion was seconded by Rosenthal, and carried.

The next regular meeting is scheduled for Wednesday, June 14, 2017.
