BOND ORDINANCE AMENDING AND SUPPLEMENTING BOND ORDINANCE NUMBER 2013-1 (WHICH PROVIDES FOR LAREINE AVENUE ROADWAY IMPROVEMENTS) HERETOFORE FINALLY ADOPTED BY THE BOROUGH COUNCIL OF THE BOROUGH OF BRADLEY BEACH, IN THE COUNTY OF MONMOUTH, STATE OF NEW JERSEY, ON MARCH 12, 2013, TO INCREASE THE APPROPRIATION THEREIN BY \$355,000 (INCLUDING AN ADDITIONAL GRANT RECEIVED OR EXPECTED TO BE RECEIVED IN THE AMOUNT OF \$250,000) AND TO INCREASE THE AUTHORIZATION OF BONDS OR NOTES THEREIN BY \$97,000 TO FINANCE PART OF THE ADDITIONAL COSTS THEREOF
