MAYOR AND COUNCIL REPORTS

Councilman Weber stated he enjoyed the Arts Council production of Ellis Island. He reminded everyone plastic film collection will be tomorrow. He advised that the State collected acorns from the Salem Oak that will be given to each town in NJ and the BBES will decide on where to plant the seedlings and the Environmental Commission will publicize the plantings. He suggested that in the future architectural plans be presented when a home in town is being taken down & replaced. He stated that he and Mr. Sexsmith had met with members of the Fire Department to discuss their budget. He congratulated his council colleagues on all of their hard work.

Councilman Sexsmith stated that the Memorial Day Committee had a meeting seeking volunteers. He thanked Amy Hall and Michele Whille for their hard work in trying to keep the parade on track.

He and Mr. Weber met with Fire Department to discuss their proposed budget and increased participation. He spoke with the Chief of Police regarding recent break-ins and through hard work the police have stopped the break-ins.

Councilman Gubitosi commended the Mayor, Administrator/Municipal Clerk and Finance Committee for support during the interview process of filling positions the Borough. He welcomed part-time tax collector Colleen Castronova and stated he thinks she will be a huge asset to the Borough. He enjoyed the Art Council's production of Ellis Island. He commended DPW Director Biagio Cafone his department for their review and repair of various beach lockers that need minor repairs. He announced a Traffic Safety Committee which will assist in keeping the streets, sidewalks & boardwalks safe for pedestrian travel and will meet on 2/27/20 at 6:30 pm at the Biase Center. The Library Director Ashley Foglia is planning library courses on bicycle safety. The Complete Count Committee met last week to discuss advertising for the 2020 Census to encourage participation in the census. He announced that the Main Street Committee recently applied for a grant to get free analysis of Main Street and the Maritime Center is looking at phase three (3) of enhancements. He stated there is a small sub-team working with the Zoning Officer to redraft the ordinance.

Councilman Bonnell stated he thinks there will be a significant change in the budget process this year. He met with DPW Director Biagio Cafone last month and this evening to discuss becoming more proactive & taking ownership of their budget. He stated there will be some nice changes with the Quality of Life Committee with the addition of Paula Gavin.

Mayor Engelstad commended and appreciates the Council for all of the proactive work they have been doing. He and the Council are very optimistic for the final stages in the search of a new Chief Financial Officer. They are in the process of collecting resumes for Business Administrator and Municipal Clerk and will begin interviews immediately. The first budget workshop will be February 25th at 6:30 p.m. and agrees with Mr. Bonnell that it will be a different process in a good way. They are considering the many budgetary requests from the various task forces. He stated there will be some savings with the personnel changes and should utilize this to afford some of the recommendations of the task force groups. He also attended the Memorial Day Committee meeting and stated there is a lot of enthusiasm with some significant changes and involvement by the business community. He stated Memorial Day Weekend will be just as busy as ever and thanked everyone involved in the process.
