

ORDINANCE NO. 2016-35

AN ORDINANCE AMENDING THE REVISED GENERAL ORDINANCES
OF THE BOROUGH OF BRADLEY BEACH ENTITLED CHAPTER 24
COMMISSIONS AND COMMITTEES

Be it ordained by the Mayor and Council of the Borough of Bradley Beach that Chapter 24, is amended as follows:

ARTICLE VIII

Quality of Life Committee

24-42 Purpose.

The Borough of Bradley Beach hereby enacts THE QUALITY OF LIFE COMMITTEE, dedicated to educating and informing citizens of the codes and ordinances established for the Borough of Bradley Beach, which set minimum requirements and standards regarding property and structures to promote and protect the public health, safety, convenience, order and general welfare of all of our citizens. These standards are designed to preserve and improve the quality of life and provide a sense of community to our residents and all of our visitors to the Borough of Bradley Beach.

24-43 Scope.

The Quality of Life Committee is comprised of volunteer members appointed by the Mayor and may be working staff members of the Police Department, Code Office, Public Works, Administrative Services and affiliated board members within the borough and residents of the Borough of Bradley Beach. The Quality of Life will work as a cooperative initiative working together to promote education of local ordinance and zoning laws as well as other ordinances generally under the enforcement of the Police and Code Departments.

24-44 Enforcement.

The Police Department and Code Officer will be responsible for the enforcement of local ordinance in the event complaints result in the necessity of the issuance of a summons. These duties shall not interfere with employee's regular assignments and duties.

24-45 Appointment/Membership.

The Quality of Life Committee shall be composed of nine (9) members, which shall consist of five (5) members of the public and four (4) members of the working staff of the Borough of Bradley Beach. The members are nominated by the Mayor and confirmed by Council, whose terms shall be staggered as provided herein.

The initial appointments to the committee shall be as follows:

Five (5) Committee Members for an initial term effective September 1, 2016 through December 31, 2017.

(Subsequent appointments for a one year (1) term January through December)

Four (4) Committee Members for an initial term effective September 1, 2016 through December 31, 2018.

(Subsequent appointments for a two (2) year term January through December)

All committee members shall serve until their successors are appointed or they resign or their terms are otherwise vacated as set out herein.

24-46 Term Limitation.

Excluding the initial term appointment, no committee member shall serve in that capacity for more than two (2) consecutive terms unless Mayor and Council deem necessary.

24-47 Meetings.

The Quality of Life Committee shall hold meetings on a monthly basis.

24-48 Council Liaison.

One (1) member of Borough Council shall be appointed “non-member status” to oversee and assist the Quality of Life Committee.

These appointments shall be made January 1 by the Mayor.

This Ordinance shall become effective upon final passage and publication according to law.
