RESOLUTION NO. 2014-

A Resolution of the Borough of Bradley Beach Language identifying Green Team Members and Meeting Schedule Establishing a Green Team Advisory Committee

Mayor Engelstad offered the following resolution and moved its adoption:

WHEREAS, a sustainable community seeks to optimize quality of life for its residents by ensuring that its environmental, economic and social objectives are balanced and mutually supportive; and

WHEREAS, Bradley Beach strives to save tax dollars, assure clean land, air and water, improve working and living environments; and

WHEREAS, Bradley Beach is participating in the Sustainable Jersey Program; and

WHEREAS, one of the purposes of the Sustainable Jersey Program is to provide resources to municipalities to make progress on sustainability issues;

WHEREAS, Bradley Beach has taken steps and passed Resolution 2014-33 to authorize the creation of a Green Team;

WHEREAS, this resolution will further identify Green Team Members and Tentative Meeting Schedule;

THEREFORE BE IT FURTHER RESOLVED, by the Borough Council, that at a minimum, the Green Team shall consist of the existing Municipal Environmental Commission which will assume the responsibilities of the Green Team but can eventually consist of up to eleven members in total who shall be residents or employees, appointed every two years, but whose initial term shall be through December 31, 2015. Meetings shall be conducted on a quarterly basis every third month at the Carmen A. Biase Center on the same date and time as the scheduled Environmental Commission meeting..

NOW THEREFORE BE IT FURTHER RESOLVED, by the Borough Council of Bradley Beach that the Mission and Objectives for the Green Team through December 31, 2015 are established as follows:

Mission

The Bradley Beach Green Team will advise the township committee on ways to improve municipal operations with “Green” initiatives which are economically and environmentally sound through research and evaluation.

Objectives

1. Collaborate with township employees, service providers and other governmental agencies to share resource information and ideas consistent with the Mission of the Green Team.
2. Encourage participation of all employees to solicit ideas on green initiatives.
3. Research and analyze green initiatives which make practical environmental and financial sense.
4. Develop strategies for sustainable green initiatives in municipal operations.

NOW THEREFORE BE IT FINALLY RESOLVED, by the Borough Council of Bradley Beach that the following persons are hereby appointed to the Green Team until December 2015 and are eligible to serve until replaced through an updated resolution or ordinance:
