RESOLUTION AUTHORIZING EXECUTION OF A PROFESSIONAL ENGINEERING SERVICES AGREEMENT WITH LEON S. AVAKIAN, INC. FOR CONSTRUCTION ADMINISTRATION AND FINAL PLANS AND SPECIFICATIONS IN RELATION TO THE BOARDWALK UPGRADES FOR NEWARK AND CLIFF AVENUES

WHEREAS, the Borough has a need to engage a professional engineering firm to provide engineering services in relation to the Construction Administration and Final Plans and Specifications , for the Boardwalk Upgrades (Newark and Cliff Aves; and

WHEREAS, engineering services to be provided for this improvement project would be in an amount not to exceed \$62,000.00 and include construction administration and,Final Plans and Specification; and

WHEREAS, the Local Public Contracts Law, N.J.S.A. 40A:11-5, authorizes the Borough to enter into contracts for professional services without public bidding; and

WHEREAS, this contract is being awarded in accordance with the requirements of N.J.S.A. 19:44A-20.5 et seq.; and

WHEREAS, the Chief Financial Officer has certified that funds for the professional engineering services have been provided for as identified in the accounting records of the Borough as follows:
