**RESOLUTION AUTHORIZING AWARD OF PROPOSAL FOR PROFESSIONAL  
ENGINEERING SERVICES WITH CME ASSOCIATES FOR  
THE BEACH AVENUE DRAINAGE IMPROVEMENTS**

**WHEREAS**, the Borough of Bradley Beach has a need to acquire professional services relative to engineering services required for the Beach Avenue Drainage Improvements; and

**WHEREAS**, CME Associates submitted a proposal dated March 6, 2023, to provide engineering services relative to the Beach Avenue Drainage Improvements; and

**WHEREAS**, said proposal consisted of the following services and costs:

<b>Design Phase Services &amp; Bid Document Preparation</b>	<b>\$10,300.00</b>
<b>Bid Phase Services</b>	<b>\$3,300.00</b>
<b>Total:</b>	<b>\$18,600.00</b>

**WHEREAS**, the Borough Mayor and Council finds it to be in the best interest of the Borough of Bradley Beach to authorize said work; and

**WHEREAS**, funding for is available by appropriation in the budget of the Borough.

**NOW, THEREFORE, BE IT RESOLVED** by the Borough Council of the Borough of Bradley Beach, County of Monmouth, State of New Jersey that the Mayor and Municipal Clerk are authorized to enter into a Contract with CME Associates as described therein.
