**RESOLUTION 2023-116**

**RESOLUTION AUTHORIZING THE DISCUSSION OF MATTERS  
IN A CLOSED EXECUTIVE SESSION PURSUANT TO N.J.S.A 10:4-12 & N.J.S.A 10:4-13**

**WHEREAS**, the Open Public Meetings Act, P.L. 1975, Chapter 231 permits the exclusion of the public from a meeting in certain circumstances; and

- Public Safety/Security
- Contract Negotiation

**NOW, THEREFORE, BE IT RESOLVED**, by the Mayor & Council of the Borough of Bradley Beach that the Mayor & Council shall retire into executive session where the public shall be excluded and where the following matters shall be discussed:

- **Marchese vs. Bradley Beach**
- **414 McCabe Avenue**

**BE IT FURTHER RESOLVED**, that the Mayor & Council shall reconvene in public session upon conclusion of the executive session discussions, which shall be approximately 30 minutes following adoption of this Resolution; and

**BE IT FURTHER RESOLVED**, that the following persons are expected to attend this Executive Session: 1) Mayor & Council, 2) Borough Interim Administrator, 3) Borough Attorney, 4) Municipal Clerk

**BE IT FURTHER RESOLVED**, that the minutes of this executive session shall be closed from public inspection and shall so remain until the reason for confidentiality ceases to exist, or upon formal action by the Mayor & Council at an official meeting.
