### **Applications Considered:**

**LUB22/22 – (Bulk Variance for Fence Height on Corner Lot) – Nicholas & Barbara Zaharioudakis – Block 88, Lot 20 – 516 Bradley Boulevard** – Applicant is seeking a bulk variance to install a 4 ½ ft. high fence in a front yard area on this corner lot where only a 3 foot high fence is permitted.

Nicholas & Barbara Zaharioudakis are sworn in with the Board Professionals.

The Applicants explain they wish to install a 4 ½ ft. high fence in this front yard area for the safety of their dogs. They are proposing an aluminum, 50% open type fence which will be placed behind the existing arborvitae.

It is discussed and agreed that the fence, if permitted, will be at least 5 feet off of the property line behind the existing shrubs which will be maintained in place.

**Based upon the testimony provided Dennis Mayer makes a motion to approve the application with the condition that the 4 ½ ft. high fence will be installed at least 5 feet off of the property line and be placed behind the existing shrubs which are to be maintained, seconded by William Psiuk.**
