RESOLUTION 2024-73

**RESOLUTION AUTHORIZING THE DISCUSSION OF MATTERS
IN A CLOSED EXECUTIVE SESSION PURSUANT TO N.J.S.A 10:4-12 & N.J.S.A 10:4-13**

Mayor Fox offered the following resolution and moved its adoption:

WHEREAS, the Open Public Meetings Act, P.L. 1975, Chapter 231 permits the exclusion of the public from a meeting in certain circumstances; and

WHEREAS, the Mayor & Council of the Borough of Bradley Beach is of the opinion that such circumstances presently exist; and

WHEREAS, the matters to be discussed relate to a statutorily excluded topic under N.J.S.A 10:4-12(b), specifically:

- Attorney-Client Privilege
- Employment/Personnel
- Imposition of Civil Penalty
- Investigation
- Leasing or Acquisition of Property
- Pending or Anticipated Litigation
- Protected Privacy Interests
- Public Safety/Security
- Contract Negotiation

NOW, THEREFORE, BE IT RESOLVED, by the Mayor & Council of the Borough of Bradley Beach that the Mayor & Council shall retire into executive session where the public shall be excluded and where the following matters shall be discussed:

- **McGuire vs. Bradley Beach**
- **Fair Share Housing**
- **Personnel Investigation discussion**
- **BBFD Appeal**

BE IT FURTHER RESOLVED, that the Mayor & Council shall reconvene in public session upon conclusion of the executive session discussions, which shall be approximately Sixty (60) minutes following adoption of this Resolution; and

BE IT FURTHER RESOLVED, that the following persons are expected to attend this Executive Session: 1) Mayor & Council, 2) Acting Borough Administrator, 3) Borough Attorney, 4) Borough OPRA Attorney, 5) Borough Fair Share Housing Attorney, and 6) Municipal Clerk.

BE IT FURTHER RESOLVED, that the minutes of this executive session shall be closed from public inspection and shall so remain until the reason for confidentiality ceases to exist, or upon formal action by the Mayor & Council at an official meeting.

BE IT FURTHER RESOLVED, minutes will be kept of said executive session, which minutes shall be confidential and shall not be disclosed to the public until the need for confidentiality no longer exists.
