**APPROVAL TO APPLY FOR A GRANT FROM THE NEW JERSEY HISTORIC  
TRUST FOR \$138,100 TO RESTORE THE BRADLEY BEACH FREE PUBLIC  
LIBRARY'S DOORS AT THE FOURTH AVENUE ENTRANCE**

**WHEREAS**, The Borough of Bradley Beach authorizes submission of this application for assistance from the New Jersey Historic Trust for a total of \$141,500; and

**WHEREAS**, The Borough of Bradley Beach further authorizes **Ashley Foglia, Bradley Beach Free Public Library** Director to complete and sign application documents on behalf of the organization.

**BE IT THEREFORE RESOVLED**, that the Borough of Bradley Beach further authorizes that, if awarded the grant, matching funds in the amount of **\$56,600** are committed by the Friends of the Bradley Beach Library and the Bradley Beach Free Public Library to complete this project within the required time frame.

- a. The facts, figures and information contained in this application, including all attachments, are true and correct;

- c. The organization agrees to abide by the time frame set forth in the grant guidelines.
