Applications

- #23007 408 Main Street: In front of Abuelita's Market. London Plains tree -Location on State Road. Tree needs attention from DPW. J. Weber and T. Gavin suggest having Council test with JCPL. to probably should not ask Landlord to take care of it. Shade Tree does not feel they should vote on State Right of Way without Council follow-up with State and JCPL. Motion by L. Bagwell to vote "Decline" application. Should not remove tree. Unanimous vote to decline.
- #23008 811 Main Street: In front of Fire House. Diameter of 10" to 11" not 27" (circumference) as noted in application. Located in proposed area for driveway. Will plant trees elsewhere on site. Resident Thomas Coan noted that he attended Land Use Board meeting and this removal is appropriate. A. Gubitosi and T. Gavin suggest that the applicant should NOT be charged for the \$50 application. Motion to approve application by L. Bagwell. Motion passes with N. Kosarych only dissenting vote. L. Bagwell will talk to applicant to see if the replacement trees can ALSO be located on the street in right-of-way; noting that the applicant must follow approved site-plan.
- #23009 413 Fourth Ave: Application to remove tree. Only explanation is "New owner" But Commission members could not reach applicant. Need to replace with a tree (not a bush) AND must be a tree on "approved list". Motion to table this vote by L. Bagwell. Unanimous approval. T. Gavin with follow-up with homeowner.
- #23010 316 Fourth Ave: Based upon map drawn this tree removal is not in planting strip. Applicant wishes to replace with trees or shrubs that are not

"approved". Tree looks healthy but not sure if Commission members understand the owner. T. Gavin will follow-up with this applicant. Motion to table this vote by L. Bagwell. Unanimous approval.

- New plantings: Goal was to get at least 20 trees planted
 - Wishing Tree Applications To Date -- 10 applications to date.
 - Honor Me Applications To Date -- 5 applications to date.
 - Deadline is first week in April (Markouts and trip to nursery is April 14 deadline)
 - L. Bagwell will send out instruction note by Friday, March 31.
 - Fall planting can plant in some public spots including Second and Third Ave Park (per J. DeNoble). Can place at least four trees in park. J. DeNoble will measure the width of planting strips and determine what trees will be available in the fall.
 - Request for "Honor Me" tree on 600 block on Second Ave planting strip is too narrow so plant across street in front of 611 Second Ave. J. DeNoble will talk to applicant.
