**AUTHORIZING AWARD OF PROFESSIONAL ENGINEERING SERVICES TO  
SUBURBAN CONSULTING ENGINEERS, INC. FOR A GRANT APPLICATION,  
INCLUDING TECHNICAL ASSISTANCE AND LOAN FORGIVENESS, FOR THE  
BOROUGH'S SANITARY SEWER INFRASTRUCTURE REPLACEMENT PROJECT**

**WHEREAS**, Suburban Consulting Engineers, Inc. was appointed as a qualified professional engineer by the Borough on January 1, 2025, via fair and open process; and

**WHEREAS**, Suburban Consulting Engineers, Inc. has submitted a proposal to perform the aforesaid Engineering Services relating to the grant application; and

**WHEREAS**, funding for this purpose will be budgeted and certified by the Chief Financial Officer in Account(s): **S-06-85-558-000-502**.

**NOW THEREFORE BE IT RESOLVED** by the Mayor and Council of the Borough of Bradley Beach, County of Monmouth, State of New Jersey that the Borough Administrator is authorized to budget and execute a Purchase Order for the aforesaid Engineering Services in an amount not to exceed \$32,600.00 (Thirty-Two-Thousand-Six-Hundred Dollars 00/100).
