RESOLUTION OF THE BOROUGH OF BRADLEY BEACH, COUNTY OF MONMOUTH, STATE OF NEW JERSEY, AUTHORIZING CONTRACT THROUGH EDUCATIONAL SERVICES COMMISSION OF NEW JERSEY COOPERATIVE CONTRACT VENDOR MRC INC. THROUGH #65MCESCCPS - ESCNJ 24/25-01

WHEREAS, the Borough of Bradley Beach may by resolution, and without advertising for bids or obtaining quotations, purchase any goods or services as per N.J.S.A. 40A:11-11, under the Educational Services Commission of New Jersey Cooperative Pricing System; and

WHEREAS, the Bradley Beach Borough has the need on a timely basis for recreational infrastructure improvements utilizing Educational Service Commission of New Jersey Contracts, duly authorized under law to extend contract pricing to local units, per N.J.A.C. 5:34-7 et. Seq.; and

WHEREAS, MRC Inc., PO Box 106, Spring Lake, NJ 07762, is the holder of “**ESCNJ 24/25-01 PLAYGROUND EQUIPMENT, SITE FURNISHINGS, OUTDOOR CIRCUIT TRAINING EQUIPMENT AND RELATED PRODUCTS**”, expiring June of 2026; and

WHEREAS, MRC Inc., has provided for a quote under the cooperative **in the amount of \$161,097.19** for improvements to Recreational Playground; and

WHEREAS, the Chief Financial Officer has certified that funds **in the amount of \$161,097.19** are available in line item: **C-04-82-936-000-903**.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Bradley Beach, County of Monmouth, State of New Jersey, as follows:

That the Borough is authorized to procure improvements to the Recreational Playground through **MRC Inc., PO Box 106, Spring Lake, NJ 07762, in the amount of \$161,097.19, under the authority of ESCNJ 24/25-01.**

BE IT FURTHER RESOLVED, that the Municipal Clerk shall forward a certified copy of this Resolution to the Borough Administrator, the CFO, the QPA, and the Recreation Director.
