**AUTHORIZING PURCHASE OF RECREATION CENTER PLAYGROUND SURFACING THROUGH STATE OF NEW JERSEY CONTRACT #16-FLEET-00131**

**WHEREAS**, a need exists for the acquisition of playground surfacing at the Borough Recreation Center Playground: and

**WHEREAS**, the Borough of Bradley Beach may, without advertising for bids, purchase such materials through the New Jersey State Purchase and Property State Contracts pursuant to N.J.S.A. 40A:11-12 and N.J.A.C. 5:34-7.29 et. Seq., and

**WHEREAS**, under the state contract award, **Rubber Recycle, 1985 Rutgers University Boulevard Lakewood, NJ 08701, holder of New Jersey State Contract #16-FLEET-00131;** and

**WHEREAS**, Rubber Recycle has provided for a quote under New Jersey State contract acceptable to the Borough in the amount of \$104,017.50, acceptable to the Borough; and

**WHEREAS**, the Chief Financial Officer has certified funds are available **in the amount of \$104,017.50 in line item: C-04-82-936-000-903.**

**NOW, THEREFORE, BE IT RESOLVED**, by the Borough Council of the Borough of Bradley Beach, County of Monmouth, State of New Jersey, as follows:

- **That the proposal is acceptable and the Administrator is hereby authorized to procure acquisition of playground surfacing at the Borough Recreation Center Playground from Rubber Recycle, 1985 Rutgers University Boulevard Lakewood, NJ 08701, holder of New Jersey State Contract #16-FLEET-00131, in the amount of \$104,017.50.**
