**AUTHORIZATION TO AWARD THE RECREATION CENTER PARK
IMPROVEMENTS TO SHORE TOP CONSTRUCTION
IN THE AMOUNT OF \$340,275.00**

Mayor Gubitosi offered the following resolution and moved its adoption:

WHEREAS, the Mayor and Council of the Borough of Bradley Beach have determined that there is a need for the acquisition of the following goods and services:

RECREATION CENTER PARK IMPROVEMENTS

WHEREAS, a notice of advertisement for a bid and an invitation to the bid were prepared and advertised in accordance with the Local Public Contracts Law; and

WHEREAS, Friday, August 29, 2025 at 10:00 a.m. in accordance with the requirements of the Local Public Contracts Law the received bids were opened publicly; and

WHEREAS, one (1) bid was received as follows:

WHEREAS, Matthew Doherty, Borough Administrator and Bennett Matlack, P.E, CME, CFM Borough Engineer, have reviewed the bids and recommend that the award of contract be made to **Shore Top Construction, 23 Yellowbrook Road Freehold, NJ 07728**, as the lowest responsible bidder; and

WHEREAS, Gregory Cannon, the Borough Attorney has reviewed the bid proposal package of the lowest bidder, and declares them to be in conformance with the Borough's Instructions to Bidders and the Local Public Contracts Law and recommends an award of contract to **Shore Top Construction** as the lowest responsible bidder; and

WHEREAS, funds are available to make such purchase or acquisition and have been certified as such by Jeanette M. Larrison, Interim Chief Financial Officer.

NOW THEREFORE, BE IT RESOLVED, by the Borough Council of the Borough of Bradley Beach, County of Monmouth, State of New Jersey as follows:

1. An award of contract for the **Recreation Center Improvements** as outlined hereinabove, is hereby made to **Shore Top Construction in the amount of \$340,275.00 as the lowest responsible bidder.**

2. The Mayor and Municipal Clerk are hereby authorized to execute the Borough standard form of Contract for Goods and Services reference herein and made a part of this award of contract as well as any non-substantive modifications thereto and related constituent documents.
3. The Municipal Clerk is directed to forward a certified copy of this Resolution to the Qualified Purchasing Agent, Chief Financial Officer, Borough Engineer, Borough Attorney and Shore Top Construction.
