RESOLUTION 2025-330

AMENDING RESOLUTION 2025-250 REQUESTING THE NEW JERSEY DEPARTMENT OF TRANSPORTATION (NJDOT) CHANGE TO THE PARKING SPACE TIME LIMIT ON THE WEST SIDE OF MAIN STREET.

WHEREAS, parking along the west side of Main Street (State Route 71) from the corner of LaReine Avenue to 147 feet north, permits a fifteen (15) minute limit for parking related to Borough business only; and

WHEREAS, this exception to the two-hour parking limit for the remainder of the west side of Main Street is documented in Chapter 9, Attachment 3 of the Borough's Ordinances; and

WHEREAS, this area could likely accommodate up to four (4) or more parked vehicles; and

WHEREAS, two-hour parking spaces on Main Street are highly valued for use by the public in visiting shops and restaurants on Main Street; and

WHEREAS, this 147 foot section of 15 minute parking on Main Street is seldom, if ever, fully utilized for "15 minute Borough business" and it would better serve the public if the parking limits for this section of parking spaces could be extended to a two-hour limit, consistent with the remainder of the west side of Main Street.

NOW THEREFORE BE IT RESOLVED, the Mayor and Council of Bradley Beach formally request the New Jersey Department of Transportation to approve a change in the limit on parking spaces from "15 minutes" to "two-hours" for parking along the west side of Main Street (State Route 71) from the corner of LaReine Avenue to 147 feet north.

Along Route 71, Borough of Bradley Beach:

For the Southbound direction of Traffic:

Two-hour time limit parking along the southbound (westerly) side from 8:00 a.m. to 6:00 p.m., Sunday through Saturday, including holidays:

Between Ocean Park Avenue and LaReine Avenue.

Repealer Clause:

The Borough of Bradley Beach concurs that any approved traffic regulations in conflict with or are inconsistent with the provisions of this resolution be rescinded upon approval of the Traffic Regulation Order (TRO).
