RESOLUTION 2025-355

**RESOLUTION EXTENDING ALL 2025 SPECIAL PARKING PERMITS
UNTIL FEBRUARY 28, 2026**

Mayor Gubitosi offered the following Resolution and moved its adoption:

WHEREAS, the Borough of Bradley Beach (the “Borough”) has administers a Special Permit Parking Program pursuant to Chapter 9, “Traffic,” of the Revised General Ordinances of the Borough of Bradley Beach; and

WHEREAS, Special Permit Parking approvals issued for the 2025 calendar year are currently set to expire on December 31, 2025; and

WHEREAS, the Mayor and Council are evaluating potential amendments to Chapter 9, “Traffic,” for possible implementation during the 2026 calendar year; and

WHEREAS, the Borough requires additional time to review the current parking system, gather public input, and finalize any proposed changes; and

WHEREAS, the Mayor and Council desire to minimize disruption for residents, property owners, and permit holders during this transition period; and

WHEREAS, extending the validity of 2025 Special Permit Parking approvals will ensure continuity of the Borough’s parking program, reduce administrative burden, and avoid confusion during the evaluation period; and

WHEREAS, the Mayor and Council find such an extension to be in the best interests of the Borough and its residents.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Bradley Beach, County of Monmouth, State of New Jersey, that all Special Parking Permits issued for the 2025 calendar year are hereby extended through and including February 28, 2026; and

BE IT FURTHER RESOLVED that all rights and conditions associated with such permits shall remain in effect during the extension period unless modified by further action of the Mayor and Council; and

BE IT FURTHER RESOLVED that, upon adoption of any amendments to Chapter 9, “Traffic,” the Borough shall implement updated procedures for 2026 permit renewals in accordance with such amendments; and

BE IT FURTHER RESOLVED that a certified copy of this Resolution shall be provided to the Chief of Police, the Borough Administrator, the Borough Clerk, and any other appropriate officials for implementation.
