**RESOLUTION 2025-99**

**RESOLUTION APPROVING A CONTRACT WITH GRANICUS TO PROVIDE PROPRIETARY COMPUTER SOFTWARE AND RELATED SUPPORT SERVICES FOR TRANSIENT ACCOMODATION HOST COMPLIANCE**

**WHEREAS**, the Borough of Bradley Beach (the “Borough”) seeks to ensure that transient accommodation hosts comply with all applicable laws, regulations and ordinances in the conduct of their business within the Borough; and

**WHEREAS**, the Borough seeks a vendor to provide proprietary computer software and related support services to enhance transient accommodation host compliance; and

**WHEREAS**, Granicus is in the business of providing proprietary computer software and related support services to enhance transient accommodation host compliance within resort communities; and

**WHEREAS**, Granicus has submitted a Proposal, in the amount of \$16,986.31, to provide the Borough with proprietary computer software and related support services to enhance transient accommodation host compliance; and

**WHEREAS**, the New Jersey Local Public Contracts Law authorizes the Borough to award a contract to Granicus for proprietary computer software and related support services without the need for competitive bids; and

**WHEREAS**, the Chief Financial Officer has certified available funds in the amount of \$16,986.31 from Account Number 5-01-22-195-000-206.

**NOW, THEREFORE, BE IT RESOLVED** that the Mayor & Council of the Borough of Bradley Beach, County of Monmouth, State of New Jersey hereby approve Granicus’s Proposal, in the amount of \$16,986.31, to provide proprietary computer software and related support services to enhance transient accommodation host compliance; and

**BE IT FURTHER RESOLVED** that the Borough Administrator is hereby authorized to execute the Granicus’s Proposal; and

**BE IT FURTHER RESOLVED** that a copy of this Resolution, together with the executed Proposal, shall be forwarded to the Borough CFO and Granicus.
