**RESOLUTION RE-APPOINTING ERICA KOSTYZ, RMC AS TENURED  
MUNICIPAL CLERK OF THE BOROUGH FOR A THREE-YEAR TERM BEGINNING  
ON APRIL 28, 2026 AND EXPIRING ON APRIL 27, 2029, TO SAID BOROUGH  
EMPLOYEE PURSUANT TO N.J.S.A. 40A:9-133.7**

**Mayor Gubitosi** offered the following Resolution and moved its adoption:

**WHEREAS**, pursuant N.J.S.A. 40A:9-133, the Borough of Bradley Beach (the “Borough”) is required to appoint and retain the services of a Municipal Clerk; and

**WHEREAS**, by Resolution No. 2023-152, dated May 10, 2023, Erica Kostyz, RMC was re-appointed to a three-year term as Municipal Clerk of the Borough under N.J.S.A. 40A:9-133; and

**WHEREAS**, the three-year term of Erica Kostyz, RMC as Municipal Clerk will that expire on April 27, 2026 as her second term as Municipal Clerk of the Borough; and

**WHEREAS**, pursuant N.J.S.A. 40A:9-133.7, upon re-appointment to a second three-year term as Municipal Clerk of the Borough, Erica Kostyz, RMC acquired tenure on May 10, 2023 in said position and shall thereafter hold office during good behavior and efficiency, and compliance with applicable continuing education requirements; and

**WHEREAS**, the Borough’s Mayor and Council are satisfied with the services of Erica Kostyz, RMC as Municipal Clerk of the Borough and desire to re-appoint her to the tenured position for an additional three-year term.

**NOW, THEREFORE, BE IT RESOLVED**, by the Borough Council of the Borough of Bradley Beach, County of Monmouth, State of New Jersey, that Erica Kostyz, RMC is hereby re-appointed as Municipal Clerk of the Borough for a term beginning on April 28, 2026 and expiring on April 27, 2029, thereby granting Erica Kostyz, RMC as tenured Municipal Clerk of the Borough pursuant to N.J.S.A. 40A:9-133.7; and

**BE IT FURTHER RESOLVED**, that a certified copy of this resolution shall be sent to the Borough Administrator, Borough CFO, New Jersey Department of Community Affairs, and Erica Kostyz, RMC.
