RESOLUTION 2026-72

APPROVING SHARED SERVICES AGREEMENT WITH THE BOROUGH OF NEPTUNE CITY FOR THE PROVISION OF COMMERCIAL CLEANERS TO CLEAN THE NEPTUNE CITY COMMUNITY CENTER.

WHEREAS, Bradley Beach employs individuals to provide commercial cleaning services at Bradley Beach municipal buildings (the “Bradley Beach Commercial Cleaners”); and

WHEREAS, Neptune City desires to employ Bradley Beach Commercial Cleaners on a limited basis for the sole purpose of cleaning the Neptune City Community Center on a weekly basis; and

WHEREAS, Bradley Beach is willing to send three (3) Bradley Beach Commercial Cleaners to Neptune City to provide commercial cleaning services at the Neptune City Community Center for ten (10) hours per week per cleaner, subject to certain conditions; and

WHEREAS, the governing bodies of both municipalities find this Agreement to be in the best interests of their residents and consistent with the Act; and

WHEREAS, the Parties wish to enter into a Shared Services Agreement, pursuant to the Act, under which Bradley Beach shall make available to Neptune City (3) Bradley Beach Commercial Cleaners for ten (10) hours per week per cleaner for the purpose of cleaning the Neptune City Community Center.

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of Neptune City in the County of Monmouth, State of New Jersey, as follows:

- 1.The foregoing recitals are hereby incorporated herein.
- 2.The Mayor is hereby authorized and directed to execute the Shared Services Agreement between the Borough of Bradley Beach and the Borough of Neptune City (the “Agreement”), as available on file with the Borough Clerk, with the Consent of the Borough, in order to provide commercial cleaning services at the Neptune City Community Center.
- 3.The Mayor is further authorized to take all actions necessary, and to prepare, negotiate and execute any other documents or agreements necessary or required, to effectuate the terms of this Resolution. The Mayor, acting Mayor and any other Borough officer, official or professional are each hereby authorized and directed to execute and deliver such documents as are necessary to effectuate the terms of this Resolution, and to take such actions or refrain from such actions as are necessary for same, in consultation with counsel, and all such actions or inactions by the aforesaid Borough officers, officials and professionals heretofore are hereby ratified and confirmed, *nunc pro tunc*.

4.All prior resolutions, or parts thereof, that are inconsistent with this Resolution are repealed to the extent of such inconsistency.

5.This Resolution shall take effect immediately.
