 NOTICE OF PENDING BOND ORDINANCE

The bond ordinance, the summary terms of which are included herein, was introduced and passed upon first reading at a meeting of the governing body of the Borough of Bradley Beach, in the County of Monmouth, New Jersey (the "Borough"), held on February 3, 2026. It will be further considered for final passage after public hearing thereon, at a meeting of said governing body to be held in the Meeting Room at 701 Main Street, Bradley Beach, NJ, on February 17, 2026, at 6:30 p.m., or as soon thereafter as said matter can be reached, at which time and place all persons who may be interested therein will be given an opportunity to be heard concerning the same. A copy of this ordinance has been posted on the bulletin board upon which public notices are customarily posted in the Municipal Complex of the Borough during the week prior to and up to and including the date of such meeting; copies of the ordinance are available to the general public of the Borough who shall request such copies, at the office of the Municipal Clerk in said Borough of Bradley Beach, in the County of Monmouth, New Jersey. The summary of the terms of such bond ordinance follows:

**Title: BOND ORDINANCE PROVIDING FOR RENOVATIONS TO THE BEACH PROMENADE AND THE ACQUISITION OF BEACH MOBI-MATS, APPROPRIATING \$450,000 THEREFOR AND AUTHORIZING THE ISSUANCE OF \$450,000 BONDS AND NOTES TO FINANCE A PORTION OF THE COSTS THEREOF, AUTHORIZED IN AND BY THE BOROUGH OF BRADLEY BEACH, IN THE COUNTY OF MONMOUTH, NEW JERSEY**

**Purpose(s):** Providing for (i) renovations to the beach promenade including, but not limited to the repair of stairs, ramps and the construction of two new ramps and (ii) the acquisition of 10' wide Mobi-Mats for the improvement of handicap access for the beach located in the Borough, together with all purposes necessary, incidental or appurtenant thereto
