

**ADVERTISEMENT AND NOTICE TO BIDDERS**

Notice is hereby given that electronically sealed bids will be opened and conducted in electronic platform in accord with N.J.A.C. 5:34-1 et. Seq., on BidNet Direct at [www.bidnetdirect.com/boroughofbradleybeach](http://www.bidnetdirect.com/boroughofbradleybeach) at which time and place the sealed bids will be opened publicly and read for the following: sealed Bids will be received by the Borough of Bradley Beach for: **"SYLVAN LAKE BULKHEAD IMPROVEMENTS" CONTRACT NO. 115.BB00507.H01** and opened and read aloud and recorded on zoom, on **MAY 7th, 2026, at 1:00 p.m.** prevailing local time.

This project involves the replacement of the existing 1,200 feet long failing wooden bulkhead along a portion of the north-easterly bank of Sylvan Lake along Bradley Boulevard from Evergreen Ave to Madison Ave. The plan involves reducing the width of Bradley Boulevard by six feet to provide room for the proposed living shoreline improvements and maintain a pavement width of 44'. Approximate construction quantities include 1,200 LF of Modular Block Bulkhead, 1,200 LF of concrete curb or curb and gutter, 675 SY of concrete sidewalk, and other associated work.

**Bids shall be electronically uploaded, no physical bids shall be received, opened or honored.**

**NOTE:**

It is the bidder's responsibility to ensure that the bid package is delivered by the bid opening date and time. Any bid document received after the deadline established by the Department of Purchasing will not be accepted, regardless of the method of delivery.

**Submission of Bid:**

Each bid must be accompanied by a certified check of not less than ten (10%) percent of the bid payable without any conditional endorsement as a guarantee that in case the contract is awarded to the bidder, he will within ten (10) days thereafter execute such contract and furnish satisfactory performance bond. Upon failure to do so, he shall forfeit the bid security as liquidated damages and the acceptance of the bid will be contingent upon the fulfillment of this requirement by the bidder. No interest shall be allowed upon any such certified check. A bid bond in the amount of ten (10%) percent of the bid may be substituted for certified check, except the amount of the bid security shall not be less than \$500.00 - nor more than \$20,000.00. Each bid must be accompanied by a Certificate of Experience and Certificate of Equipment. If bids are to be submitted electronically in accord with this notice, then the bidder shall submit a copy of the bid guarantee with electronic submittal and mail PRIOR to bid opening the original the Municipal Clerks office 701 Main St.

Bradley Beach, NJ 07720. The bid bond may also be provided in certified check and cashiers check in accord with provisions within general requirements of this bid.

Each bid must also be accompanied by a certificate of Consent of Surety from a bonding company licensed to do business in the State of New Jersey guaranteeing that if the proposal of the bidder be accepted they will furnish the bond set forth in the Instructions to Bidders and the acceptance of the bid will be contingent upon the fulfillment of this requirement.

The Borough reserves the right to increase or decrease quantities specified in the manner designated in the Specifications. The Borough reserves the right to award this contract based on funds available.

Bidders are required to comply with the requirements of the Americans with Disabilities Act (N.J.S.A.10:5-31 et seq.) and Affirmative Action (N.J.A.C. 17:27) and with the disclosure provisions of N.J.S.A. 19:44A-20.13. The successful bidder shall be required to comply with the provisions of the New Jersey Prevailing Wage Act, Chapter 150 of the Laws of 1963, effective January 1, 1964.

Bidders shall comply with N.J.S.A. 52:32-44 latest revision, regarding Business Registration with the [New Jersey Division of Revenue](#).

During the performance of this contract the Contractor agrees to comply with the requirements of P.L. 1975, c. 127 (N.J.A.C. 17:27), all requirements of the State of New Jersey Worker Health and Safety Act (N.J.A.C. 12:110 et seq.) as amended and the United States Occupational Safety and Health Act (OSHA) (29 CFR 1910), as amended with regard to worker and jobsite safety.

No bidder may withdraw his bid for a period of sixty (60) days after the date set for the opening thereof, outside of applicable law. The successful bidder will be required to furnish a surety company bond in the full amount of the contract price indemnifying the Borough of Bradley Beach, New Jersey for all proceedings, suits or actions of any kind of description and conditional for the faithful performance of the work.

The Borough Council of the Borough of Bradley Beach reserves the right to reject any or all bids if in violation of N.J.S.A. 40A:11-1 et. Seq.,
