RESOLUTION 2020-214

RESOLUTION EXTENDING THE SUMMER BEACH SEASON PURSUANT TO CODE SECTION 123-2 AND PERMITTING THE USE OF THE BOROUGH'S BATHING BEACHES AND FACILITIES UNTIL SEPTEMBER 30, 2020

Mayor Engelstad offered the following Resolution and moved its adoption:

WHEREAS, the Borough of Bradley Beach (the "Borough"), as well as its residents, businesses, and visitors, have been adversely affected in many ways throughout the 2020 summer season by the ongoing COVID-19 crisis; and

WHEREAS, the Mayor and Council desire that the Borough's residents, businesses, and visitors have the maximum amount of time to enjoy and engage in commerce at the Borough's beachfront during an extremely difficult year;

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Borough of Bradley Beach as follows:

- (1) Nothing herein shall be construed or interpreted inconsistently with or in violation of any Executive Order issued by the Governor of the State of New Jersey, or any other law, rule, regulation, guideline, directive, or notice from any authority to which the Borough is subject or would otherwise be bound or guided.
- (2) The Borough's bathing beaches, including beach lockers, concessions, and such other facilities as necessary in the discretion of the Borough Administrator, shall remain open to the public for use until September 30, 2020, provided that, beginning September 8, 2020, the Borough's bathing beaches shall be under "Rough Surf Management Rules" from Monday through Friday and "Normal Beach Operation Rules" on Saturday and Sunday.
- (3) All other portions of Chapter 123 of the Borough Code remain in full force and effect, as amended by the Borough's published COVID-19 Beach Regulations and any and all lawful declarations, resolutions, and orders.
- (4) The Borough Administrator is authorized to post such notices, take such measures, and execute such agreements as may be necessary to accomplish the objectives of this Resolution.
