### **RESOLUTION 2021-171**

A RESOLUTION OF CONCURRENCE WITH NEW JERSEY DEPARTMENT OF TRANSPORTATION RECOMMENDATION FOR A REVISION OF TIME LIMIT PARKING BETWEEN BRADLEY BEACH BOROUGH-NEPTUNE TOWNSHIP CORPORATE LINE AND EVERGREEN AVENUE AND ESTABLISH STREET CLEANING REGULATIONS ALONG ROUTE 71 WITHIN THE BOROUGH OF BRADLEY BEACH.

Mayor Fox offered the following resolution and moved its adoption:

**WHEREAS**, the New Jersey Department of Transportation has completed an investigation and determined that the Time Limit for parking between the Neptune Township Corporate Line and Evergreen Avenue be revised from one hour and three hours to two hours and to establish Street Cleaning Regulations along NJ Route 71 within the Borough of Bradley Beach to ensure motorist and pedestrian safety.

**WHEREAS**, in order to legally revise the Time Limit Parking and establish Street Cleaning Regulations, the Department of Transportation is required to promulgate a Traffic Regulation Order (TRO) and has requested the Borough of Bradley Beach to adopt a resolution of concurrence pursuant to N.J.S.A. 39:4-8C.

**NOW, THEREFORE BE IT RESOLVED,** that the Mayor and Council of the Borough of Bradley Beach hereby concurs with the recommendation and supports the following Traffic Regulation Orders.

**BE IT FURTHER RESOLVED,** that a certified copy of this resolution be forwarded to New Jersey Department of Transportation and the Police Department.
