RESOLUTION 2021-181

A RESOLUTION OF CONCURRENCE WITH NEW JERSEY DEPARTMENT OF TRANSPORTATION RECOMMENDATION FOR A REVISION OF ALL EXISTING BUS STOPS ALONG NJ ROUTE 71 (MAIN STREET) WITHIN THE BOROUGH OF BRADLEY BEACH.

Mayor Fox offered the following resolution and moved its adoption:

WHEREAS, the New Jersey Department of Transportation has completed an investigation and determined that all existing Bus Stops along NJ Route 71 (Main Street) be revised to establish and ensure motorist and pedestrian safety within the Borough of Bradley Beach.

WHEREAS, in order to legally revise the existing Bus Stops along Route 71 (Main Street) and establish Bus Stop Regulations, the Department of Transportation is required to promulgate a Traffic Regulation Order (TRO) and has requested the Borough of Bradley Beach to adopt a resolution of concurrence pursuant to N.J.S.A. 39:4-8C.

NOW, THEREFORE BE IT RESOLVED, that the Mayor and Council of the Borough of Bradley Beach hereby concurs with the recommendation and supports the revision of Bus Stop Regulations along NJ Route 71 (Main Street) within the Borough of Bradley Beach..

BE IT FURTHER RESOLVED, that a certified copy of this resolution be forwarded to New Jersey Department of Transportation and the Police Department.

BUS STOPS:

Along Route NJ 71 northbound, on the easterly side at:

- A. **Evergreen Avenue – (near side) (NJ Transit ID# 24401)**
Beginning at the southerly curb line of Evergreen Avenue and extending 105 feet southerly therefrom.
- B. **Brinley Avenue – (far side) (NJ Transit ID# 24403)**
Beginning at the northerly curb line of Brinley Avenue and extending 100 feet northerly therefrom.
- C. **Ocean Park Avenue – (far side) (NJ Transit ID# 24405)**
Beginning at the northerly curb line of Ocean Park Avenue and extending 100 feet northerly therefrom.

Along Route NJ 71, southbound, on the westerly side at:

- A. Ocean Park Avenue - (near side) (NJ Transit ID# 24406)
Beginning at the prolongation of the northerly curb line of Ocean Park Avenue and extending 105 feet northerly therefrom.**
- B. Brinley Avenue - (near side) (NJ Transit ID# 24407)
Beginning the northerly curb line of Brinley Avenue and extending 105 feet northerly therefrom.**
- C. Fourth Avenue - (far side) (NJ Transit ID# 24408)
Beginning at the southerly curb line of Fourth Avenue and extending 100 feet southerly therefrom.**

Repealer Clause:

The Borough of Bradley Beach concurs that any approved bus stop locations or traffic regulations in conflict with or inconsistent with the provisions of this *Resolution* be rescinded upon approval of the Traffic Regulation Order.
