**AUTHORIZATION TO AWARD THE BEACH ACCESS RAMPS/OCEAN PARK
AND FOURTH AVENUE BID TO VULCAN CONSTRUCTION GROUP, INC.
IN THE AMOUNT OF \$128,840.00**

Mayor Fox offered the following resolution and moved its adoption:

WHEREAS, Kimberly M. Humphrey, QPA, Borough Administrator and Gerald J. Freda, P.E, Borough Engineer, have determined that there is a need for the acquisition of the following goods and services:

BEACH ACCESS RAMPS/OCEAN PARK AND FOURTH AVENUE; and

WHEREAS, the project will consist of Beach Access Ramps for A.D.A. compliance, to Ocean Park Avenue and Fourth Avenue; and

WHEREAS, a notice of advertisement for bids and an Invitation to Bid were prepared and advertised in accordance with the Local Public Contracts Law; and

WHEREAS, sealed bids were opened and read on Wednesday, August 12, 2021 at 11:00 a.m. in accordance with the requirements of the Local Public Contracts Law; and

WHEREAS, seven were received as follows:

WHEREAS, Kimberly M. Humphrey, QPA, Borough Administrator and Gerald J. Freda, P.E, Borough Engineer, have reviewed the bids and recommend that the award of contract be made to Vulcan Construction in the amount of \$128,840 as the lowest responsible bidder; and

WHEREAS, Greg Cannon, the Borough Attorney has reviewed the bid proposal package of the lowest bidder, and declares them to be in conformance with the Borough's Instructions to Bidders and the Local Public Contracts Law and recommends an award of contract to Vulcan Construction Group, Inc. as the lowest responsible bidder; and

WHEREAS, funds are available to make such purchase or acquisition and have been certified as such by Sandra Rice, CFO, and said certification being attached to the resolution.

NOW THEREFORE, BE IT RESOLVED, by the Borough Council of the Borough of Bradley Beach, County of Monmouth, State of New Jersey as follows:

1. An award of contract for Beach Access Ramps, as outlined hereinabove, is hereby made to **Vulcan Construction Group, Inc., 3 Hance Drive, Cookstown, NJ 08511** in the amount of \$128,840 as the lowest responsible bidder.
2. The Mayor and Borough Clerk are hereby authorized to execute the Borough standard form of Contract for Goods and Services reference herein and made a part of this award of contract as well as any non-substantive modifications thereto and related constituent documents.
3. The Borough Clerk is directed to forward a certified copy of this Resolution to the Qualified Purchasing Agent, Chief Financial Officer, Borough Engineer, Borough Attorney and Vulcan Construction Group, Inc.
