WHEREAS, the project will consist of Drainage and Sump Pump improvements to Monmouth Avenue and Burlington Avenue.

WHEREAS, a notice of advertisement for bids and an Invitation to Bid were prepared and advertised in accordance with the Local Public Contracts Law; and

WHEREAS, sealed bids were opened and read on Tuesday, October 5, 2021 at 10:30 a.m. in accordance with the requirements of the Local Public Contracts Law; and

WHEREAS, Greg Cannon, the Borough Attorney has reviewed the bid proposal package of the lowest bidder, and declares them to be in conformance with the Borough's Instructions to Bidders
