NOW THEREFORE, BE IT RESOLVED that the Council of the Borough of Bradley Beach authorizes the Purchasing Agent on behalf of the Borough to issue and execute a Purchase Order for the foregoing, with funds certified available by the Chief Financial Officer utilizing Capital Account C-01-82-928-000-093 — Ordinance 2018-23; and

BE IT FURTHER RESOLVED that the Business Administrator is hereby authorized to arrange to pay for the foregoing in accordance with the terms of the purchase order.

BE IT FURTHER RESOLVED that the Business Disclosure Entity Certification be on file with this resolution and will be published in accordance with the Applicable law.
