**RESOLUTION 2021-43**

**AUTHORIZATION TO AWARD THE NEWARK AVENUE PHASE I BID TO  
APCO PAVING COMPANY, INC. IN THE AMOUNT OF \$241,222.83**

Mayor Fox offered the following resolution and moved its adoption:

**WHEREAS**, David G. Brown II, QPA, Borough Administrator and Gerald J. Freda, P.E, Borough Engineer, have determined that there is a need for the acquisition of the following goods and services:

**NEWARK AVENUE PHASE I ROAD IMPROVEMENT PROJECT; and**

**WHEREAS**, the project will consist of drainage improvements, concrete curb, sidewalk replacement and the upgrade of sidewalk ramps for A.D.A. compliance, pavement milling and pavement to a portion of Newark Avenue, Kent and Cliff Avenues; and

**WHEREAS**, a notice of advertisement for bids and an Invitation to Bid were prepared and advertised in accordance with the Local Public Contracts Law; and

**WHEREAS**, sealed bids were opened and read on Wednesday, December 23, 2020 at 10:30 a.m. in accordance with the requirements of the Local Public Contracts Law; and

**WHEREAS**, ten (10) bids were received as follows:

**WHEREAS**, Greg Cannon, the Borough Attorney has reviewed the bid proposal package of the lowest bidder, and declares them to be in conformance with the Borough's Instructions to Bidders and the Local Public Contracts Law and recommends an award of contract to APCO Paving Co. as the lowest responsible bidder; and

**WHEREAS**, funds are available to make such purchase or acquisition and have been certified as such by Sandra Rice, CFO, and said certification being attached to the resolution.

**NOW THEREFORE, BE IT RESOLVED**, by the Borough Council of the Borough of Bradley Beach, County of Monmouth, State of New Jersey as follows:


