**RESOLUTION 2022-125**

**RESOLUTION AUTHORIZING RE-ADVERTISEMENT FOR SOLICITATION OF PROPOSALS FOR A CONCESSION AT OCEANFRONT AND BRINLEY AVENUE, WITH TWO ADDITIONAL OPTIONAL LOCATIONS, FOR THE RENTAL OF BEACH CHAIRS AND UMBRELLAS**

**WHEREAS**, the Borough of Bradley Beach (the “Borough”) advertised a Notice to Bidders for a concession on public property located at the Oceanfront and Brinley Avenue, together with additional optional locations on Newark Avenue and Evergreen Avenue, for the rental of Beach Chairs and Umbrellas; and

**WHEREAS**, any interested bidders were required to submit a bid deposit in the amount of \$500.00 to the Borough Clerk to be eligible for public bidding to be held at the Borough Council Meeting on April 26, 2022; and

**WHEREAS**, the Borough Clerk did not receive any responses from potential bidders for the aforementioned concession prior to the Borough Council Meeting on April 26, 2022; and

**WHEREAS**, the Borough finds that the provision of such a concession is in the best interests of residents and visitors during the summer beach season;

**NOW, THEREFORE BE IT RESOLVED** that the Mayor and Council of the Borough of Bradley Beach, County of Monmouth, State of New Jersey hereby authorize the Borough Administrator to re-advertise for solicitation of bids for a concession on public property located at the Oceanfront and Brinley Avenue, together with additional optional locations on Newark Avenue and Evergreen Avenue, for the rental of Beach Chairs and Umbrellas; and

**BE IT FURTHER RESOLVED** that the Borough Administrator is hereby authorized to reduce the minimum bid from \$3,000.00 to \$XX.XX in the Notice to Bidders to be re-advertised for the aforementioned concession.
