RESOLUTION 2022-168

A RESOLUTION PROVIDING FOR EMERGENCY TEMPORARY APPROPRIATIONS FOR CURRENT FUND \$675,349.20 AND WATER / SEWER FUND \$222,532.29 AND BEACH UTILITY OPERATING FUND \$87,516.76

WHEREAS, there will be a delay in the adoption of the 2022 Borough of Bradley Beach, County of Monmouth, New Jersey, Local Municipal Budget; and

WHEREAS, a temporary budget in the amount of 26.25% of the total appropriations in the 2021 budget, exclusive of any appropriations made for interest and debt redemption charges, capital improvement fund and public assistance was adopted in January 2022; and

WHEREAS, if additional funds are not budgeted, the public welfare will be adversely affected; and

WHEREAS, it is the recommendation of the Chief Financial Officer that this emergency temporary appropriation be authorized in the amount of \$675,349.20 for Current Fund and \$222,532.29 for Water / Sewer Fund and Beach Fund \$87,516.76 in accordance with amount below; and

WHEREAS, this appropriation brings the 2022 year to date temporary appropriation for Current Fund to \$3,825,509.79 and \$222,532.29 for Water / Sewer Fund and \$87,516.76 for Beach Utility Operating Fund . This brings the Current Fund temporary appropriations to 31.06% of the 2021 budget, and the Water / Sewer Fund temporary appropriations to 33.41% of the 2021 budget and the Beach Utility Operating Fund temporary appropriations to 28.06% of the 2021 budget.

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of Bradley Beach, County of Monmouth, State of New Jersey, that in accordance with N.J.S.A. 40A:4-20, an emergency temporary appropriation be and same is hereby made for in the amount of \$675,349.20 for Current Fund and \$222,532.29 for Water / Sewer Fund and \$87,516.76 Beach Utility Operating Fund and that said emergency temporary appropriation shall be provided in full in the 2022 budget.
