## ADOPTING THE TEMPORARY OPERATING BUDGET FOR THE YEAR 2022.

WHEREAS, N.J.S.A. 40A:4-19 provides that where any contract, commitment or payments are to be made prior to the final adoption of the annual municipal budget, temporary appropriations should be made for the purpose and amounts required in the manner and time therein provided; and

**WHEREAS**, as required by said statute, this resolution is adopted during the first thirty (30) days of the 2022 fiscal year; and

**WHEREAS,** the total appropriations in the 2021 budget, exclusive of any appropriations made for interest and debt redemption charges, capital improvement fund, and public assistance were as follows:
