**RESOLUTION AWARDDING A CONTRACT TO  
GREENSPOT JC, LLC OF JERSEY CITY, NEW JERSEY  
FOR INSTALLATION OF ELECTRIC VEHICLE INFRASTRUCTURE**

**WHEREAS**, the Borough of Bradley Beach (the “Borough”) advertised a Request for Proposals (“RFP”) for the installation of electric vehicle charging infrastructure and related services attendant thereto; and

**WHEREAS**, on September 22, 2022, the Borough received bids for the aforementioned project as follows:

**WHEREAS**, pursuant to the Local Public Contracts Law, N.J.S.A. 40A:11-1, *et seq.*, Greenspot JC, LLC has been determined to be the lowest responsible bidder,

**NOW, THEREFORE, BE IT RESOLVED** by the Governing Body of the Borough of Bradley Beach, County of Monmouth, State of New Jersey that a contract is hereby awarded to Greenspot JC, LLC of Jersey City, New Jersey, for the installation of four (4) electric vehicle charging stations and related services attendant thereto, at proposed cost of \$0.25 charged to users, subject to further approval by the Borough of an acceptable contract and locations for the electric vehicle charging stations and

**BE IT FURTHER RESOLVED**, that the Borough Clerk shall publish a notice of this action in the official newspaper of the Borough within ten (10) days from the adoption of this Resolution; and

**BE IT FURTHER RESOLVED** that the Borough Clerk forward a certified true copy of this resolution to the Borough Administrator, Borough CFO, Borough Engineer, Project Engineer, Greenspot JC, LLC, and to the unsuccessful bidders.
