**RESOLUTION AUTHORIZING THE DISCUSSION OF MATTERS

NOW, THEREFORE, BE IT RESOLVED, by the Mayor & Council of the Borough of Bradley Beach that the Mayor & Council shall retire into executive session where the public shall be excluded and where the following matters shall be discussed:

Dish Network – Cell Tower Lease

BE IT FURTHER RESOLVED, that the Mayor & Council shall reconvene in public session upon conclusion of the executive session discussions, which shall be approximately fifteen (15) minutes following adoption of this Resolution; and

BE IT FURTHER RESOLVED, that the minutes of this executive session shall be closed from public inspection and shall so remain until the reason for confidentiality ceases to exist, or upon formal action by the Mayor & Council at an official meeting.

BE IT FURTHER RESOLVED, minutes will be kept of said executive session, which minutes shall be confidential and shall not be disclosed to the public until the need for confidentiality no longer exists.
