**RESOLUTION ACCEPTING LOW BID AND AUTHORIZING  
THE PURCHASE OF A REFURBISHED HOOK-LIFT TRUCK TO BE  
UTILIZED BY THE BOROUGH'S DEPARTMENT OF PUBLIC WORKS**

**Mayor Fox** offered the following Resolution and moved its adoption:

**WHEREAS**, the Borough of Bradley Beach (the "Borough") advertised for bids for the purchase of a refurbished hook-lift truck to be utilized by the Borough's DPW; and

**WHEREAS**, on April 13, 2023, the Borough received one (1) bid for the aforementioned goods and/or services from Coast Cities Equipment Sales, Inc. in the amount of \$77,500.00; and

**WHEREAS**, pursuant to the Local Public Contracts Law, N.J.S.A. 40A:11-1, *et seq.*, and upon recommendation of the Director of Public Works, Coast Cities Equipment Sales, Inc. has been determined to be the lowest responsible bidder,

**NOW, THEREFORE, BE IT RESOLVED** that the Governing Body of the Borough of Bradley Beach, County of Monmouth, State of New Jersey hereby authorizes the purchase of a refurbished, 2014 hook-lift truck with a 2018 rebuilt engine for the Borough's DPW in the amount of \$77,500.00, also with a three-year warranty and that the Mayor and the Acting Borough Administrator are authorized to execute such documents as are necessary to effectuate said purchase transaction; and

**BE IT FURTHER RESOLVED**, that the Chief Financial Officer has issued a Certificate of Available Funds in an amount not to exceed \$77,500.00 and which is incorporated herein by reference; and

**BE IT FURTHER RESOLVED** that the Borough Clerk forward a certified true copy of this resolution to the Borough Administrator, Borough CFO, DPW Director, and Coast Cities Equipment Sales, Inc.
