**RESOLUTION 2023-140**

**RESOLUTION AWARDING A CONTRACT TO  
BLACK ROCK ENTERPRISES OF OLD BRIDGE, NEW JERSEY  
FOR BRADLEY BOULEVARD IMPROVEMENTS**

**Mayor Fox** offered the following Resolution and moved its adoption:

**WHEREAS**, the Borough of Bradley Beach (the “Borough”) solicited quotes from three contractors for a public project for the making of certain improvements to Bradley Boulevard; and

**WHEREAS**, the Project Engineer set a deadline of April 14, 2023 for the receipt of quotes for the aforementioned project, at or before which deadline, the following were received:

**WHEREAS**, pursuant to the Local Public Contracts Law, N.J.S.A. 40A:11-1, *et seq.*, and upon recommendation of the Project Engineer and Borough Attorney, Black Rock Enterprises has been determined to be the lowest responsible respondent, with price and other factors considered;

**NOW, THEREFORE, BE IT RESOLVED** by the Governing Body of the Borough of Bradley Beach, County of Monmouth, State of New Jersey that a contract is hereby awarded to Black Rock Enterprises, 1316 Englishtown Road, Old Bridge, New Jersey 08857, in the amount of \$40,250.00, for a public project for the making of certain improvements to Bradley Boulevard, and that the Mayor and the Clerk of the Borough are authorized to execute and attest to an agreement with Black Rock Enterprises pursuant to project specifications in a form approved by the Borough Attorney; and

**BE IT FURTHER RESOLVED**, that the Borough Clerk shall publish a notice of this action in the official newspaper of the Borough within ten (10) days from the adoption of this Resolution; and

**BE IT FURTHER RESOLVED**, that the Chief Financial Officer has issued a Certificate of Available Funds in an amount not to exceed \$40,250.00 and which is incorporated herein by reference; and

**BE IT FURTHER RESOLVED** that the Borough Clerk forward a certified true copy of this resolution to the Borough Administrator, Borough CFO, Project Engineer, Black Rock Enterprises, and to the unsuccessful respondent.
