**RESOLUTION AUTHORIZING THE DISCUSSION OF MATTERS

- **COAH**

BE IT FURTHER RESOLVED, that the Mayor & Council shall reconvene in public session upon conclusion of the executive session discussions, which shall be approximately 40 minutes following adoption of this Resolution; and

BE IT FURTHER RESOLVED, that the following persons are expected to attend this Executive Session: 1) Mayor & Council, 2) Interim Borough Administrator, 3) Fair Share Housing Attorney (Via Zoom), 4) Borough Borough Planner (Via Zoom), 5) Borough Attorney, 6) Municipal Clerk.

BE IT FURTHER RESOLVED, that the minutes of this executive session shall be closed from public inspection and shall so remain until the reason for confidentiality ceases to exist, or upon formal action by the Mayor & Council at an official meeting.

BE IT FURTHER RESOLVED, minutes will be kept of said executive session, which minutes shall be confidential and shall not be disclosed to the public until the need for confidentiality no longer exists.
