**RESOLUTION 2023-166**

**RESOLUTION RATIFYING THE WAIVER OF \$50.00 APPLICATION FEES UNDER BOROUGH CODE SECTION 425-10(F) OF CHAPTER 425: “TREES” FOR CERTAIN PROPERTIES REQUIRED TO REMOVE OR REMEDIATE HAZARDOUS TREES**

**Mayor Fox** offered the following Resolution and moved its adoption:

**WHEREAS**, Chapter 425: “Trees” of the Revised General Ordinances of the Borough of Bradley Beach (the “Borough”) requires property owners to obtain a permit for certain activities relating to the removal and/or trimming of trees within the Borough; and

**WHEREAS**, Section 425-10(F) under Chapter 425 of the Borough’s Revised General Ordinances requires a \$50.00 application fee to be paid by property owners to obtain a permit from the Borough for certain activities relating to the removal and/or trimming of trees; and

**WHEREAS**, the Borough recently conducted certain studies and determined that a number of property owners should be required to remove and/or trim potentially hazardous trees existing upon their respective properties and/or along Borough streets; and

**WHEREAS**, the Borough sought to promote compliance and reduce the burdens for Borough property owners to address the potentially hazardous trees at issue; and

**WHEREAS**, the Borough’s Mayor & Council find that waiving any and all application fees under Borough Code Section 425-10(F) will reduce the costs for property owners and encourage the remediation of potentially hazardous trees in the interests of the health, welfare and safety of residents and visitors within the Borough;

**NOW, THEREFORE, BE IT RESOLVED**, by the Mayor and Council of the Borough of Bradley Beach that the Application Fee of \$50.00 set forth in Borough Code Section 425-10(F) is hereby waived for the following property owners required to remove and/or trim hazardous trees upon their respective properties and/or along Borough streets:
