RESOLUTION 2023-196

**A RESOLUTION CORRECTING CERTIFICATION OF FUNDS FOR
RESOLUTIONS 2023-94 AND 2023-95 AND APPROVING CHANGE ORDER NO. 1
FOR LAKE TERRACE PARK IMPROVEMENTS.**

WHEREAS, on 8 March 2023 adopting Resolution 2023-94 the Borough of Bradley Beach authorized a contract with TC Landscape Contracting to provide improvements to Lake Terrace Park in the amount of \$159,486.00, and

WHEREAS, on 8 March 2023 adopting Resolution 2023-95 awarded a contract to CME Engineering to perform construction administration for this project in the amount of \$15,000.00, and

WHEREAS, each resolution contained a certification of funds for Account #C-04-82-918-000-902 which was in error, and

WHEREAS, it is necessary to modify these certification of funds, and

WHEREAS, the project engineer and administrative staff have recommended the approval of Change Order No. 1 for the Lake Terrace Park Improvements which consist of chain link fence, brick pavers, screening plantings, walkway improvements, and topsoil seed, etc.

NOW THEREFORE BE IT RESOLVED by the Governing Body of the Borough of Bradley Beach in the County of Monmouth that:


