## RESOLUTION REJECTING ALL BIDS RECEIVED AND AUTHORIZING READVERTISEMENT AND SOLICITATION OF BIDS FOR THE INSTALLATION OF ELECTRIC VEHICLE INFRASTRUCTURE

**Mayor Fox** offered the following Resolution and moved its adoption:

WHEREAS, the Borough of Bradley Beach (the "Borough") solicited bids for the installation of electric vehicle charging infrastructure and related services attendant thereto; and

**WHEREAS,** on September 22, 2022, the Borough received one (1) bid for the aforementioned project as follows:

BIDDER	TERMS OF BID
Greenspot JC, LLC	User charges to be determined by bidder; Borough charged \$0 for installation and maintenance; Borough reimbursed \$0.15/kWh; Borough receives 10% of operating margin until bidder recoups investment and then receives 20% thereafter;

**WHEREAS**, N.J.S.A. 40A:11-13.2 provides that bids may be rejected if, *inter alia*, the Borough finds that the lowest bid substantially exceeds the cost estimates; decides to abandon the project; or wants to substantially revise the specifications for the project; and

**WHEREAS**, the Borough has determined that such circumstances presently exist under N.J.S.A. 40A:11-13.2 justifying the rejection of all bids received;

**NOW, THEREFORE, BE IT RESOLVED** that the Mayor and Council of the Borough of Bradley Beach, County of Monmouth, State of New Jersey hereby reject all bids received for the foregoing project; and

**BE IT FURTHER RESOLVED**, that the Borough shall readvertise and rebid the foregoing project upon modified terms acceptable to the Mayor & Council; and

**BE IT FURTHER RESOLVED** that the Borough Clerk forward a certified true copy of this resolution to the Borough Administrator, Borough CFO, Borough Engineer, Project Engineer, and Greenspot JC, LLC.
