AUTHORIZING AWARD OF PROPOSAL FOR PROFESSIONAL ENGINEERING SERVICES WITH CME ASSOCIATES FOR THE STORMWATER INFRASTRUCTURE MAP UPGRADES TO CONFORM WITH THE NJDEP REQUIREMENTS

Mayor Fox offered the following resolution and moved its adoption:

WHEREAS, the Borough of Bradley Beach has a need to acquire professional services relative to engineering services required for the Stormwater Infrastructure Map Upgrades to conform with the NJDEP Requirements; and

WHEREAS, CME Associates submitted a proposal dated August 17, 2023, to provide engineering services relative to the Stormwater Infrastructure Map Upgrades to conform with the NJDEP Requirements; and

WHEREAS, said proposal consisted of the following services and costs:

Stormwater Infrastructure Map Upgrades to conform with NJDEP requirements.

Amount: \$25,000.00

WHEREAS, the Borough Mayor and Council finds it to be in the best interest of the Borough of Bradley Beach to authorize said work; and

WHEREAS, funding will be available through a Stormwater Assistance Grant that the Borough applied for and was awarded a Grant in the amount of \$25,000.00.


