BE IT FURTHER RESOLVED, that the following persons are expected to attend this Executive Session: 1) Mayor & Council and 2) Potential Candidate as scheduled.

BE IT FURTHER RESOLVED, that the minutes of this executive session shall be closed from public inspection and shall so remain until the reason for confidentiality ceases to exist, or upon formal action by the Mayor & Council at an official meeting.
