**RESOLUTION 2024-34**

**PROFESSIONAL SERVICE CONTRACT APPOINTMENT FOR AN  
AFFORDABLE HOUSING ATTORNEY**

Mayor Fox offered the following resolution and moved its adoption:

**WHEREAS**, there exists a need for professional services for a **Fair Share Housing Attorney** for the calendar year 2024 pursuant to the provisions of **N.J.S.A 19:44A-20.5**; and

**WHEREAS**, the Borough has, through the fair and open process, publicly advertised for a Request for Proposals and Qualifications and said requests for Professional Services were received in the Office of the Municipal Clerk no later than 11:00 a.m. on December 19, 2023; and

**WHEREAS**, the Borough has reviewed all proposals received and has determined that the Mayor and Council desires to authorize the execution of a professional services contract between the listed person(s)/firm(s) and the Borough for the year of 2024.

**NOW THEREFORE BE IT RESOLVED**, by the Mayor and Council of the Borough of Bradley Beach as follows:

- 1.** Weiner Law Group, LLP, is hereby appointed **Fair Share Housing Attorney** for the calendar year 2024 and is awarded a Professional Service Contract for professional legal services provided for the period of January 1, 2024 through December 31, 2024.
- 2.** The contract is awarded without competitive bidding since the appointments involve members of recognized professions that are registered by law, therefore exempt under **N.J.S.A. 40A:11-5**.
- 3.** The services rendered shall be in compliance with the Laws of New Jersey.
- 4.** A copy of this resolution and the contract shall be placed on file with the Municipal Clerk.
- 5.** A copy of this resolution shall be published in the newspaper as required by law within ten (10) days of its passage.
- 6.** This award is being made subject to the above-named professional/firm's execution of the Professional Services Contract Addendum setting forth the assignment and reporting Requirements of all professionals working for the Borough.
