RESOLUTION 2025-132

AUTHORIZING CONTRACTS WITH CERTAIN APPROVED STATE CONTRACT VENDOR LEONARDO US CYBER AND SECURITY SOLUTIONS LLC FOR THE PURCHASE OF TWO LICENSE PLATE READERS FOR THE BOROUGH OF BRADLEY BEACH VIA STATE COOPERATIVE CONTRACT PURSUANT TO N.J.S.A. 40A:11-12a.

Mayor Gubitosi offered the following resolution and moved its adoption:

WHEREAS, pursuant to N.J.S.A. 40A:11-12a and N.J.C.A. 5:34-7.29(c), the Borough may by resolution and without advertising for bids, purchase any goods or services under the State of New Jersey Cooperative Purchasing Program for any State Contracts entered into on behalf of the State by the Division of Purchase and Property in the Department of Treasury; and

WHEREAS, the Borough of Bradley Beach has the need on a timely basis to purchase goods or services Utilizing State Contracts; and

WHEREAS, the Borough of Bradley Beach intends to enter into contracts with the attached Referenced State Contract Vendors through this resolution and properly executed contracts which shall be subject to all the Conditions applicable to the current State Contracts; and

WHEREAS, the Borough of Bradley Beach authorizes the Purchasing Agent to purchase certain goods or services from LEONARDO US CYBER AND SECURITY SOLUTIONS LLC, 4221 Tudor Lane, Greensboro, NC 27410 State Contract Number GS-07F-000YY, an approved New Jersey State Contract Vendor, pursuant to all conditions of the individual State Contracts; and

WHEREAS, the Chief Financial Officer and Borough Administrator have determined that sufficient funds are available using budget account number 5-07-55-512-000-204 in the amount of \$47,143.00.

NOW THEREFORE BE IT RESOLVED, that the Borough of Bradley Beach authorizes the purchase of TWO LICENSE PLATE READERS provided on estimate number 31405 in the amount of \$47,143.00.

BE IT FURTHER RESOLVED, that the Governing Body of the Borough of Bradley Beach pursuant to N.J.C.A. 5:30-5.5(b), the certification of available funds shall certify the full maximum amount against the budget made by the Chief Financial Officer.

BE IT FURTHER RESOLVED, that the duration of the contracts between the Borough of Bradley Beach and LEONARDO US CYBER AND SECURITY SOLUTIONS LLC, shall be during the calendar year 2025 until the goods are received.
