**RESOLUTION AWARDING A NON-FAIR AND OPEN PROFESSIONAL SERVICES
CONTRACT TO GOVERNMENT EDUCATION SOLUTIONS, LLC AND
APPOINTING JEANETTE M. LARRISON AS TEMPORARY CHIEF FINANCIAL
OFFICER OF THE BOROUGH
AT A COST NOT TO EXCEED \$120,000.00**

Mayor Gubitosi offered the following Resolution and moved its adoption:

WHEREAS, the Borough of Bradley Beach (the “Borough”) requires the services of a certified municipal finance officer to serve as the Chief Financial Officer (“CFO”) of the Borough; and

WHEREAS, pursuant to N.J.S.A. 40A:9-140.10, the Borough desires to temporarily appoint a private entity to perform the duties of CFO within the Borough; and

WHEREAS, Government Education Solutions has provided the Borough with a Proposal to perform such CFO services for the Borough during 2025 at a total cost not to exceed \$120,000.00; and

WHEREAS, the Borough finds that Government Education Solutions, LLC possesses the required qualifications and experience necessary to perform the needed CFO services; and

WHEREAS, the Borough desires to award a non-fair and open professional services contract to Government Education Solutions, LLC to perform CFO services for the Borough; and

WHEREAS, the Borough desires to appoint Government Education Solutions, LLC as the Temporary CFO of the Borough from April 29, 2025 to December 31, 2025;

NOW, THEREFORE, BE IT RESOLVED, by the Governing Body of the Borough of Bradley Beach, County of Monmouth, State of New Jersey, that:

- (1) The Borough hereby awards a professional services contract to Government Education Solutions, LLC as the Temporary CFO of the Borough from April 29, 2025 to December 31, 2025, at a total cost not to exceed \$120,000.00; and
- (2) The Borough shall provide notice that the retention of Government Education Solutions, LLC is being awarded under a non-fair and open process in accordance with New Jersey’s Pay-to-Play law; and

- (3) The Borough shall publish notice of this contract award in the designated official newspapers as required by law within ten (10) days of this Resolution; and
- (4) The Borough shall require Government Education Solutions, LLC to submit a Business Entity Disclosure Certification which certifies compliance with New Jersey's Pay-to-Play law; and
- (5) A certified copy of this resolution shall be forwarded to the Borough Administrator, Government Education Solutions, LLC, and the N.J. Department of Community Affairs.
