BOROUGH OF BRADLEY BEACH

RESOLUTION 2025-182

DESIGNATING HANDICAPPED PARKING, ACCESS, AND DROP OFF AREAS AT THE BOROUGH'S BEACHFRONT: (1) WITHIN ITS CLIFF AVENUE PARKING LOT; AND (2) ADJACENT TO THE PUBLIC BEACH ENTRANCE AT THE INTERSECTION OF OCEAN AVENUE AND EVERGREEN AVENUE

Mayor Gubitosi offered the following Resolution and moved its adoption:

WHEREAS, the Borough of Bradley Beach (the "Borough") owns, operates, and maintains a public beachfront along the Atlantic Ocean; and

WHEREAS, the Borough desires to provide additional beach accessibility to disabled and handicapped persons, especially those in wheelchairs or utilizing mobility assistance, so that all of the Borough's citizens and visitors can more easily enjoy the beach; and

WHEREAS, pursuant to N.J.S.A. 39:4-197, the Borough is authorized to designate, by resolution, "restricted parking spaces for use by persons who have been issued special vehicle identification cards by the New Jersey Motor Vehicle Commission pursuant to the provisions of N.J.S.A. 39:4-204 et seq. and N.J.S.A. 39:4-197.5; and

WHEREAS, pursuant to Borough Code Section 9-3.9, the Bradley Beach Police Department is authorized to enforce all restricted handicapped and accessible parking areas designated by the Borough under N.J.S.A. 39:4-197; and

WHEREAS, the Borough finds it to be in the best interests of its citizens and visitors to designate two (2) additional handicapped parking and access areas along its public beachfront;

NOW THEREFORE BE IT RESOLVED by the Mayor and Council of the Borough of Bradley Beach, County of Monmouth, State of New Jersey that the Borough Administrator and Chief of Police are hereby authorized to designate and erect appropriate signage for disabled/handicapped restricted parking and drop-off: (1) within the Borough's Cliff Avenue public parking lot adjacent and in proximity to the access point for the public beachfront; and (2) adjacent to the public beach entrance located at the intersection of Ocean Avenue and Evergreen Avenue; and

BE IT FURTHER RESOLVED that, in accordance with Borough Code Section 9-3.9 and N.J.S.A. 39:4-197, the Bradley Beach Police Department is hereby authorized to monitor and enforce such restricted parking as set forth hereinabove.
