RESOLUTION 2025-184**

**A RESOLUTION AUTHORIZING A GRANT APPLICATION TO THE NEW JERSEY
ECONOMIC DEVELOPMENT AUTHORITY FOR UP TO \$50,000
FOR PRE-DEVELOPMENT PLANNING TO RENOVATE
THE RETIRED UTILITY BUILDING AT 54 OCEAN AVENUE.**

Mayor Gubitosi offered the following Resolution and moved its adoption:

WHEREAS, the New Jersey Economic Development Authority (“NJEDA”) announced that it accepted applications for its Asset Activation Planning Grant Program; and

WHEREAS, the Borough of Bradley Beach, County of Monmouth, State of New Jersey (the “Borough”) made an application to the NJEDA’s Asset Activation Planning Grant Program; and

WHEREAS, the Borough made a grant application to the NJEDA for up to \$50,000 for the pre-development planning to renovate the retired utility building at 54 Ocean Avenue;

WHEREAS, the Borough was awarded a grant in the amount of \$50,000 and hereby accepts said grant allotment;

WHEREAS, the Borough designates Matthew Doherty, Business Administrator as the Borough’s Authorized Representative to execute an agreement with the NJEDA and administer the grant;

NOW, THEREFORE BE IT RESOLVED, that the Governing Body of the Borough of Bradley Beach, County of Monmouth, State of New Jersey hereby authorizes the preparation and filing of a grant application with the NJEDA on behalf of the Borough to seek up to \$50,000 for the pre-development planning to renovate the retired utility building at 54 Ocean Avenue, accept said grant award, and execute a grant agreement with the NJEDA and administer the grant; and

BE IT FURTHER RESOLVED, that a certified copy of this resolution be sent to the Chief Financial Officer, Qualified Purchasing Agent, and Business Administrator.
