**BOROUGH OF BRADLEY BEACH**

**RESOLUTION 2025-190**

**AUTHORIZING PARTICIPATION IN THE NORTH JERSEY WASTEWATER COOPERATIVE PRICING SYSTEM OF PASSAIC VALLEY SEWERAGE COMMISSION (PVSC).**

**WHEREAS**, the Borough of Bradley Beach is authorized pursuant to the provisions of N.J.S.A. 40A:11-11(5), to enter into a Cooperative Pricing Agreement with the governing body of another contracting unit; and

**WHEREAS**, the Passaic Valley Sewerage Commission (PVSC) serves as the lead agency of the North Jersey Wastewater Cooperative Pricing System (NJWCPS) and is specifically authorized to establish cooperative purchasing programs pursuant to N.J.A.C. 5:34, and approved by the NJ Division of Local Government Services; and

**WHEREAS**, the NJWCPS has advertised and awarded contracts for a variety of goods and equipment; and

**WHEREAS**, the Borough desires to participate in a Cooperative Pricing System with the NJWCPS and desires to designate PVSC as "Lead Agency" for the conducting of certain functions relating to the purchase of work materials and supplies in a cost efficient manner for the benefit of Borough rate payers; and

**WHEREAS**, the Borough of Bradley Beach desires to become a member of the NJWCPS, in accord with the New Jersey Local Public Contracts Law; and

**NOW, THEREFORE, BE IT RESOLVED**, by the Borough of Bradley Beach, County of Monmouth, and the State of New Jersey, as follows:

1. Pursuant to the provisions of N.J.S.A. 40A:11-11(5), the Governing Body of the Borough of Bradley Beach, is hereby authorized to enter into the attached Agreement with the Passaic Valley Sewerage Commission (PVSC), hereinafter referred to as the "Lead Agency," for membership in the North Jersey Wastewater Cooperative Pricing System.
2. As Lead Agency, PVSC shall be responsible for complying with the provisions of the Local Public Contracts Law (N.J.S.A. 40A:11-1 et. Seq.,) and all other relevant provisions of the revised statutes of the State of New Jersey.
3. This Resolution shall take effect immediately upon final passage and publication according to law.
